


WHO ARE OUR STUDENTS?

- Approximately 12% of students enrolled at LCTCS colleges enroll directly from high school.
- Average age 27
- 54% minorities
- 58% females
- 70% of students enrolled in fall will enroll in spring (factoring out graduates)
- 53% of students enrolled in prior fall will enroll in subsequent fall semester (factoring out graduates)




LOUISIANA'S WORKFORCE POPULATION






HIGH-DEMAND JOB OPENINGS

ADULT EDUCATION IN LOUISIANA

- Act 732 of the 2010 Regular Legislative Session transferred the function of educating Louisiana's adult population without a high school degree from secondary to post-secondary education via the LCTCS.
- Currently produces approximately 6,500 high school equivalencies annually.
- Since 2010, there has been no additional state investment for adult education services.

- What are the tuition practices of colleges in neighboring states?







2013-2014 Resident Annual Tuition and Mandatory Fees Two-Year Colleges






LCTCS FUNDING BY SOURCE WITH ANNUAL TUITION + FEES
