It is rewarding to find that we have some universities who are preparing new teachers in specific content areas whose students demonstrate as much or more growth in achievement than students taught by experienced teachers as measured by our Value-Added Teacher Preparation Assessment. We anticipate that more universities will have similar findings once they receive the results for their redesigned programs for the first time during summer 2010. Our teacher preparation programs are also to be commended for the outreach that they have provided to students and teachers in schools that surround their universities. These efforts help to strengthen the lives of children both within and outside the school environment.

Mission of University

The mission of Our Lady of Holy Cross College (OLHCC) is to participate in the teaching mission of the Catholic Church in the spirit of the Marianites of Holy Cross by educating the minds and the hearts of its students through dedicated and creative teaching for responsible service to the human family; by seeking truth, goodness, and beauty through critical thinking, dialogue, and research, and by serving the community through effective stewardship and generous sharing of its time, talents, treasures, as well as its spiritual and material resources.

Student Characteristics of University

During Fall 2008, the university had a total enrollment of 991 undergraduate and 306 graduate students. A total of 237 students were males and 1060 were females. The majority of the students were from Louisiana with a total of 1265 in-state students, 24 out-of-state students, and 8 foreign students. Among students enrolled in the undergraduate program, 288 were black, 750 were white, and 259 were other races. Among students enrolled in the graduate program, 88 were black, 170 were white, and 48 were other races.

Accreditation and Approval of Teacher Preparation Program

The university is accredited by the Commission on Colleges of the Southern Association of Colleges and Schools (SACS). In addition, the university is accredited by the National Council for the Accreditation of Teacher Education (NCATE). All of the university's teacher preparation programs are approved by the Board of Regents and the Louisiana Department of Education.

Notable Features and Accomplishments of Teacher Preparation Program

- In July, 2009, the Elementary Education Program at Our Lady of Holy Cross College achieved national recognition from the Association for Childhood Education International (ACEI).
- Also in July, 2009, the Educational Leadership Program at OLHCC achieved national recognition from the Educational Leadership Constituent Council (ELCC).
- The OLHCC Department of Education has been chosen to pilot a new reaccreditation process for the National Council for Accreditation of Teacher Education (NCATE). This new process consists of early submission of an Institutional Report, an offsite visit, feedback from the offsite visit, and the submission of an Institutional Report Addendum. To conclude this process, OLHCC will host an NCATE onsite visit in Spring, 2010.
- The concept of professional development schools (PDS) continues to be an important component of the OLHCC pre-service program. OLHCC has continued its collaboration with two Jefferson Parish elementary schools: William Hart and Estelle. A reading clinic is in place at William Hart, and a mathematics clinic is in place at Estelle Elementary School. Both of these ventures demonstrate a mutually beneficial relationship: our pre-service teachers garner more clinical experience and the at-risk students gain one-on-one assistance in their area of need.

Notable Features and Accomplishments of Teacher Preparation Program (Cont'd)

The Archdiocesan Teachers Institute (ATI) program, which began in 2003, continues to offer courses leading to state certification to Catholic school teachers in an effort to work closely with the Archdiocese of New Orleans to provide certification for all teachers. The teachers receive their courses at a greatly reduced tuition, and it is anticipated that the registrants this summer will fall in the range of 90-100 teachers seeking certification. This program, begun seven years ago, has been embraced by the teachers of the archdiocese. OLHCC sees this as a true college/K-12 partnership.

LOUISIANA BOARD OF REGENTS 2009-2010 TEACHER PREPARATION ACCOUNTABILITY SYSTEM

OVERVIEW

In compliance with the Higher Education Opportunity Act of 1998, Louisiana created a Teacher Preparation Accountability System to assess the performance of teacher preparation programs within the state. During the first phase (2001-2002) of the accountability system, the performance of the regular and alternate certification students on the state teachers' examination (*Praxis*) was assessed. During subsequent phases (2002-2003, 2003-04, and 2004-05), the *quantity* of program completers at each institution was assessed and the *institutional performance* of each university was examined based upon passage rates on the *Praxis* and survey data from new teachers (who rated their teacher preparation programs on the extent to which the programs prepared the new teachers to address the state standards for teachers). The accountability system was created to include additional factors in the future that would examine growth of achievement of students taught by new teachers and perceptions of mentors of new teachers about the programs that prepared the new teachers. The purpose of the accountability system was to clearly demonstrate to the public that all universities and colleges in Louisiana were working diligently to produce quality teachers who worked effectively with PK-12 students.

During 2005-06, it was not possible to implementation the Teacher Preparation Accountability System due to the closure of universities and schools in Louisiana and the inability to collect data from displaced teachers and mentors due to Hurricane Katrina and Hurricane Rita. A decision was made to revise the Teacher Preparation Accountability System. Institutional data, quantity data, and PRAXIS examination passage rate data have been collected and disseminated to the public in the 2005-06, 2006-07, 2007-08, 2008-09, and 2009-2010 Institutional Reports for the Preparation of Teachers. During 2003-2010, a Value-Added Teacher Preparation Assessment Model has been piloted that links growth of achievement of children taught by new teachers to the universities that prepared the new teachers. Initial results were released to the public during October 2007, December 2008, and August 2009. During 2009-10, the value-added model will be integrated into the Teacher Preparation Accountability System, and the revised Teacher Preparation Accountability System will be piloted during 2009-2010.
