## Additional BoRSF Funding for Unmatched Endowed Professorships

#### **Staff Summary**

On March 21, 2012, the Board of Regents approved two key actions relative to the Endowed Professorships subprogram: (a) the staff was authorized to conduct a statewide survey of all unmatched Endowed Professorship slots; and (b) a moratorium was imposed on new applications (lifted October 2012). A total of 346 unmatched Professorship slots were submitted by the July 2, 2012 survey deadline. Of these, 181 slots have been matched since 2012 through additional expenditures of \$7,240,000. Currently 155<sup>1</sup> unmatched slots remain from the July 2012 survey, requesting an additional \$6,200,000.

In April 2014, the Board approved 180 Support Fund awards reflecting a projected budget of \$23,000,000. Based on the Treasury's June 17, 2014 notification, the Board has available an additional \$3,000,000 in the Support Fund for FY 2013-14.

Following this notification, Sponsored Programs Committee Chair Roy Martin requested the staff to develop a plan for distribution of these monies to address a portion of the remaining Professorship backlog, which affects two campuses: LSU-BR and LSUHSCNO. If the recommended funding is approved (see Attachment I), 80 slots based on the July 2012 survey, requesting \$3,200,000 in Support Fund match, would remain unmatched at LSU-BR; all other requests submitted prior to the 2012 moratorium will have been fulfilled.

#### Senior Staff Recommendation

The Senior Staff recommends approval of an additional \$3,000,000 in FY 2013-14 to match seventy-four (74) Endowed Professorships requests at LSU-BR, and one (1) at LSUHSCNO, based on the July 2012 survey.
