Report to the Louisiana Board of Regents On the Management and Operation of LOUIS: The Louisiana Library Network July 1, 2015 – June 30, 2016

Executive Overview

Interagency Agreement Number LOUIS-FY 15-17 / LSU proposal 42032

For twenty-four years, LOUIS: The Louisiana Library Network has served as the foundation on which Louisiana academic libraries support research, teaching, and learning. Diminished funding for higher education has made LOUIS more important than ever as LOUIS delivers value: equitably, collaboratively, and cost-effectively.

LOUIS, a collaboration among Louisiana's academic libraries, was established in 1992 and strives to ensure that Louisiana's academic libraries are the premier source for authoritative information to support the research, teaching, and learning needs of faculty and students; foster an environment of communication, cooperation, and collaboration within the state; identify, evaluate, and implement state-of-the-art information technologies; be a leader in providing library information services and a model of collaboration.

LOUIS is governed by the LOUIS Executive Board, which is made up of the Deans and Directors of the LOUIS member libraries.

LOUIS supports all libraries in Louisiana's higher education systems: Louisiana Academic Independent Colleges and University Network; Louisiana State University System; Louisiana Technical and Community College System; Southern University System; the University of Louisiana System; and LUMCON. In addition, LOUIS works closely with the State Library of Louisiana and parish libraries. LOUIS continually considers the needs of K-12 when negotiating for e-resources. A link to a full list of members is provided at the end of this summary.

LOUIS saves money for the taxpayers of Louisiana by collaborating on services and purchases for academic libraries. In 2016 alone, LOUIS purchased over \$44 million worth of services and resources on behalf of Louisiana's academic libraries for \$4.26 million, a savings of over \$40 million. Since 1992, LOUIS has saved the state of Louisiana over \$328 million. Additional savings are a result of LOUIS acting as the purchasing agent for subsets of libraries' selective purchases.

Via this service, LOUIS purchased approximately \$4.7 million worth of resources for these subsets for \$2.3 million. A savings of over \$2 million. All total, in 2016 LOUIS initiatives saved the state of Louisiana and all institutions in higher education more than \$42 million. Savings continue to increase as libraries ask LOUIS to negotiate more on their behalf.

A central support staff of nine FTE located in Information Technology Services at LSU reports to the LOUIS Executive Board for operational and strategic direction and the LSU Chief Information Officer for administrative direction. The LOUS central staff is in place to execute the will of the Board. Based on recommendations from LALINC interest groups, task forces, and working groups, and approval from the Board, LOUIS staff installs, upgrades, configures, consults, supports, and negotiates prices for the services, technologies, and resources on behalf of the consortium. With over 144 years combined experience, LOUIS staff has an unequaled level of institutional knowledge and expertise which equates to fast and efficient implementation of new solutions and problem solving. While membership fees do rise due to the market, members support paying membership fees due to the exemplary level of service provided. A list of services and resources is provided at the end of this summary.

LOUIS staff are advocates for academic libraries as well as all library communities by working with the Board of Regents, the Louisiana Library Association (LLA), the LLA Legislative Committee, LLA Lobbyist, the Division of Administration, the Department of Education, the State Library, public libraries, and various regional and national communities.

The LALINC / LOUIS 2013-2016 Strategic Plan 2015 Report was published in October 2015 and can be found on the LOUIS webpage and the link is provided below.

The LOUIS Executive Board requires LOUIS staff to support three main initiatives: an Integrated Library System (ILS), Interlibrary Loan (ILL), and Electronic Resources (ER). Many additional services make up each of the three main services.

The Louisiana Board of Regents supports LOUIS activities via a contract. The Scope of Services for that contract required that LOUIS:

- A. Maintain, support, and manage the Integrated Library System
- B. Negotiate statewide licenses for and provide access to electronic resources
- C. Maintain and support Interlibrary Loan software
- D. Maintain and support an integrated search and URL resolver

An additional Regent contract has resulted in LOUIS initiating a new service:

E. Affordable Learning LOUISiana

LOUIS has also developed a media campaign to:

F. Promote LOUIS statewide and nationally

In support of all initiatives, and in conjunction with the contract requirements, the following is a list of major activities completed by LOUIS during the past year. LOUIS was successful in licensing, maintaining, and supporting the following services and activities.

 - i. Coordinated and attended North and South users group meetings, webinars, and various training
 - j. Attended and presented at COSUGI and various other conferences
 - k. Worked with SirsiDynix SaaS team to develop hub servers for easier management of LOUIS virtual machines in SaaS

- 1. Actively participated in SirsiDynix's Strategic Partner Program helping to define future functionality of the Symphony system
- m. Purchased e-Learning seats for online courses
- n. Performed data cleanup for sites as needed
- o. Hosted two System Administrator meetings
- p. Addressed 539 FootPrints incidents related to the Library Services Platform
- q. Worked with the Statistics Task Force to identify needs and issues related to gathering and compiling statistics and recommended next steps to address needs
- r. Purchased BLUEcloud Analytics and began product roll-out as requested by sites
- s. Negotiated new pricing for Loyola University of New Orleans, as part of their migration to the LOUIS infrastructure
- t. Negotiated new terms and services in the SirsiDynix contract to account for the new infrastructure
- u. Worked with SirsiDynix and Loyola University of New Orleans to migrate them from their locally hosted system to the SirsiDynix SaaS environment, supported by LOUIS.
- v. Negotiated pricing for BLUEcloud Commerce for one site
- w. Hosted a week long online Symphony Sharing event
- x. Professional acknowledgement of LOUIS at COSUGI 2016:
 - SirsiDynix's VP of Product Development gave a commendation to LOUIS in his Director's Day presentation touting LOUIS as a key partner in the integration being done with another LOUIS vendor/product, EBSCO Discovery Service.
 - SirsiDynix's VP of Global Sales acknowledged to LOUIS in the Executive Q&A general session saying that partners like LOUIS serve as a model for other large academic libraries and consortia.
 - SirsiDynix's VP of Global Accounts & Academic Library Initiatives mentioned LOUIS in one of his presentations, saying LOUIS continues to be a key partner and a model for academic libraries.
 - Several SirsiDynix customers queried LOUIS staff about the recent migration from locally hosted infrastructure to SirsiDynix's SaaS, cloud hosting. One user said "LOUIS is the poster child for large academic libraries considering a move to SaaS!"
 - When asked if the LSU Law Center could be a pilot site for the new BLUEcloud Circulation product, the VP of Product Management and Library Relations said, "We'll do anything for Natalie! She has done so much for SirsiDynix and the user community!"
 - While discussing a potential partnership with Zephier, a leader in the development and deployment of the Semantic Web, the Zephier VP of Library and Vendor partnerships described the LOUIS Consortium as a "special snowflake", in a positive sense, due to the size, uniqueness, and eagerness of LOUIS to stay ahead of the curve, despite statewide financial challenges.

- ii. Facebook 553 likes; post reach averages between 40-60 viewers per post; actual engagement (likes, shares, comments) remains low averages 1-3 per post
- iii. Facebook created a Facebook page for the Affordable Learning LOUISiana initiative;
 51 likes; post reach and engagement is not significant at this time because it is a new page
- iv. Google+ 7 followers; 26,831 views; local search views total 15,783 and have generated 101 total clicks for our website, Google maps directions, and phone calls

2016-17 Initiatives

1. Curriculum Driven Acquisitions: \$45,176.28

Using a deposit account with EBSCO's Yankee Book Peddler, LOUIS will enable direct purchase of facultyassigned eTextbooks through the GOBI portal. This program has been developed in response to library sites needing a streamlined method to identify faculty-assigned textbooks, select those items for purchase, and seamlessly deliver the content to students and faculty. In collaboration with EBSCO and the OhioLink library consortia, LOUIS is developing an online discovery portal to assist students and faculty in identifying library-owned eTextbooks and freely available high-quality open education resources (OER).

For Fall semester, each LOUIS site will be limited to purchases totaling no more than \$1000. Un-utilized funds as of January 1st will be available on a first-come, first-served basis in the spring semester for this program, or other e-book investments, until they are exhausted. Through this program, each site will provide course IDs and enrollment figures to demonstrate return on investment.

2. Open Textbook Network: \$25,000 (including 40 Faculty Stipends @ 200/each)

Through the statewide textbook affordability survey, LOUIS identified faculty awareness and institutional support for open educational resources as a primary barrier to reducing student textbook expenses. To address this finding, LOUIS recommends joining the Open Textbook Network (OTN) to provide statewide training to faculty, teaching and learning staff, and librarians on utilizing Open Educational Resources as commercial textbook replacements. OTN provides "on-campus workshops to both introduce faculty to the use of open textbooks, and build support staff and administrative support for their adoption. Following these workshops, an average of 40% of attending faculty adopt open textbooks into their courses, resulting in near-immediate savings for students without compromising academic freedoms or integrity." Through the statewide textbook affordability survey, LOUIS identified over 200 faculty who are interested in learning more about OER and textbook affordability. Along with librarian constituents, this group will be targeted for participation in OTN hosted training. Current Library consortia clients of OTN include the Boston Library Consortia (BLC) and VIVA, the Virtual Library of Virginia.

3. Creative Commons Faculty/Librarian Development: \$8,000

Awareness of copyright restrictions on reuse and sharing of faculty-developed educational materials is a critical component to successfully adopting and disseminating OER. This was identified through the textbook affordability survey as an area where faculty have limited understanding of policy and implications. By hosting and developing programming through the Creative Commons Librarian Certification Program, librarians become positioned to lead development and education on their campus.

Affordable Learning Louisiana 2015-2016 Program Outcomes

The Affordable Learning LOUISiana initiative was developed with proof-of-concept funds from the Louisiana Board of Regents under the direction of Commissioner of Higher Education, Dr. Joseph C. Rallo, to demonstrate how LOUIS: the Louisiana Library Network could partner with libraries and faculty to use eTextbooks and open access materials to reduce student expenditures for required course materials. In the summer of 2015, The Louisiana Board of Regents allocated \$45,000 to LOUIS: The Louisiana Library Network to reduce direct expenses of students for textbooks. This was brought about by alarming statistics on the extreme rate of inflation for commercial textbooks and the impact those expenses were having on student loan debt, student willingness to purchase required texts, and the unfortunate consequences these factors have on student success and retention (Senack, 2014).

One LOUIS strategy to reduce student textbook expenses was the development of a program to fund the purchase of eBooks or adoption of open educational resources (OER) that could be utilized in the classroom. The forty-five Louisiana Deans and Directors of libraries at institutions of higher learning, including both two-year and four year schools, were offered the opportunity to replace course texts with low or no-cost options, a curriculum driven acquisitions model. Each project was eligible for funding of approximately \$1000 and funding was available for every institution to participate. Two rounds of funding for this particular strategy have taken place, Round One in Fall 2015 and Round Two in Spring 2016. Several possible activities were suggested as well as the option to design an alternative program so long as the outcomes demonstrated saving to students.

Suggested activities included:

- a) To identify and add to the library's collection eBooks that could be substituted for required print textbooks or monographs. Recommended criteria: Digital Rights Management (DRM) free; unlimited use; perpetual access.
- b) To create an Open Educational Resource (OER) and add it to a publically accessible OER collection.
- c) To identify and use OERs in place of commercially produced print materials normally used in the classroom.
- d) To use a subscription eBook vendor that allows rental of a specific eBook for the semester.¹

To date fourteen projects have been completed for a total expense of \$10,029.54 in Round One and \$2,032.23 in Round Two (see Table 1). Additionally, projects funded during Round One continued to generate saving to students during Spring 2016. Combined program savings to date from Rounds One, Two, and residual savings currently total \$258,215.93.

¹ In Round One, option "d" to rent eTextbooks was offered. This was removed from the possible activities in Round Two due to a low return on investment and the need for ongoing funds to support that model.

Completed project reports show that 3035 students saved \$268,477.70 for a total project Return on Investment (ROI) of \$256,415.93. Projects in category "a", and "c" demonstrated the greatest ROI with a total of \$7,503.67 expended and \$248,153.33 saved by students for an ROI of \$255,407.00. Additionally because projects in category "a" and "c" involved the use of eBooks that are owned in perpetuity by the library or OERs that can be freely reused, the initial expenditure will likely result in future savings as courses tend to be taught in multiple semesters with the same course materials assigned. If courses are repeated two times, students will be saved out of pocket expenditures totaling approximately \$300,000 with a one-time expenditure of \$7,503.67. Reuse savings have already been demonstrated at Fletcher, LSU Health, and UNO. To date, no project to create new open access education resources or textbooks have been submitted, option "b". Creating new open textbooks, is a significant investment of faculty time and the modest honoraria that LOUIS is able to provide are not adequate for this type of activity. Less successful, but still exhibiting a positive ROI, were the projects involving the rental of eTextbooks on behalf of students, type "d" above. Those projects tended to have a higher cost per textbook and do not result in new library-owned materials which have the capacity to be re-used in subsequent semesters. Hybrids of "a" and "d" type projects were also trialed. These involved the purchase of individual eTextbooks, which were then owned by the students. Similar to the rental model, these textbooks have a higher cost of ownership and no residual possibility for student savings. Based on these outcomes, LOUIS eliminated option "d" from future funding opportunities, as well as projects where purchased materials would not be owned by the library.

In the fall of 2015, a second allocation of \$100,000 was made to LOUIS for continued development of eTextbooks models. Three initiatives have been pursued thus far under this funding: direct acquisitions of eBook collections, sponsorship of an international open access eBook initiative, and the further development of a curriculum driven acquisitions program (CDA).

In order to develop the collection of LOUIS-owned eBook collections, LOUIS consulted with the Eresource Interest Group on the purchase of new eBook titles for the Gale Virtual Reference Collection. The initial collection was purchased with Board of Regents funding in 2009 for \$231,000 and included 586 volumes. This is the only shared collection of eBooks which is currently available statewide. Through a collaborative collection development effort, the decision was made to add or update 61 volumes for \$49,761.95 or \$18.12 per volume/per institution.

With the support of the LOUIS Executive Board, LOUIS also invested \$5,000 in the <u>Knowledge Unlatched</u> <u>Round 2</u>, eBook collection on behalf of Louisiana institutions of higher education. When fully funded, Knowledge Unlatched will provide open access to a collection of 78 new Humanities and Social Sciences eBooks from 13 University presses. In its pilot project, Knowledge Unlatched received pledges from almost 300 libraries and provided open access availability to 28 scholarly monographs. One recognized solution to reducing the rising cost of scholarly publications is to support open access publishing models. By supporting open access models such as Knowledge Unlatched, LOUIS is able to offer another mechanism to reduce student and library costs. **With a \$5000 investment, LOUIS supported the provision of 78 eBooks at \$1.42 per book/per institution.**

In addition, LOUIS has developed the first of its kind eBook curriculum driven acquisitions (CDA) program, modeled after a <u>successful program implemented at Louisiana State University (LSU)</u>. In this statewide program, LOUIS allocates funds to individual libraries to work with faculty in order to purchase low-cost eBooks that can be used by students in lieu of traditional commercial textbooks. The books are then owned in perpetuity by each library and can be used free-of-charge by students. **At LSU a similar model program, combined with active librarian outreach, has resulted in \$1.5M of potential student savings.**

In order to promote the Affordable Learning LOUISiana program, LOUIS invested staff time promoting <u>International Open Access Week</u> and <u>Open Education Week</u> to highlight the opportunities for faculty to utilize peer-reviewed open access textbooks like those in the OpenStax collection produced by Rice University in conjunction with funding partners including The William and Flora Hewlett Foundation and the Bill & Melinda Gates Foundation. LOUIS staff also led professional development focused activities to highlight how librarians could engage with faculty to promote low and no-cost textbook alternatives as well as to share results of Round One and Round Two projects Additionally, LOUIS staff invested significant time in educating member libraries and building relationships within the state, and in the national community of experts studying affordable learning and open educational resources (OER). Example partnerships and activities include joint programming with Affordable Learning Georgia, the Board of Regents ELearning group, and passage of <u>HCR 80</u> to further explore affordable learning solutions with the Louisiana Library Association, the Board of Regents, the Department of Education, and the State Library.

Lastly, given the success of the initial round of funding and the demonstrated capacity of libraries to make great impacts on reducing the cost of higher education, LOUIS recommends the allocation of multi-year funding to support eBook collection development that will reduce direct expenses to the student. A suggested annual allocation of \$100K for cooperative collection development and ongoing funding for OTN honoraria to faculty would enable LOUIS to continue their program through the statewide curriculum driven acquisitions program and open education resource support.
